We are sending this letter to you because you are a participant in the Seafarers Money Purchase Pension Plan ("Plan"). The Plan provide benefits to employees of signatory maritime employers who have collective bargaining agreements with the Seafarers International Union, Atlantic, Gulf, Lakes and Inland Waters or an affiliated Union. You may be eligible for benefits now or may become eligible for benefits in the future from the Seafarers Money Purchase Pension Plan.

The following are brief summaries of the plan documents enclosed with this letter:

- Seafarers Benefit Plans Beneficiary Form Complete and return if you want to designate someone to receive a benefit in the event of your death for your eligible Plan(s).
- A Guide to Your Benefits from the Seafarers Money Purchase Pension Plan ("Summary Plan Description" or "SPD") (06/2021) - Summarizes the Seafarers Money Purchase Pension Plan's rules and regulations regarding retirement benefits available to you. You can also voluntarily contribute to the Plan by sending in a personal check or deducting a percentage of your vacation benefit from the Seafarers Vacation Plan.

A notice describing any benefit changes after each SPD's publication will be mailed to you if you have not consented to electronic delivery.

You can also register for a Member Portal Account online at <a href="www.seafarers.org">www.seafarers.org</a>. The portal gives you access to update your contact information, view your dues history, enables you to view results of your physical exams, and allows you to request various services such as physical exams and drug tests.
